



OC grand jury indicts 36

The Orange County grand jury this week charged Mark Dewey Martinez, 44, of Orange, with indecency with a child stemming from a January, 2008, incident.

According to District Attorney John Kimbrough's office, Martinez is accused of exposing himself sexually to children. The indictments reported that several drug and felony theft charges were also issued.

Individuals listed are from Orange, unless otherwise indicated.

Felony criminal mischief and felony theft charges went to Raymond Timothy Craig, 29, of Nacogdoches. He is accused of causing extensive property damage at a home improvement store, and also stealing several items.

Donald Keith Rhodes, 46, was charged with delivery of a controlled substance. Clifton Dewayne Locks, address unknown, faces the same charge in a separate case.
