Christmas officially starts this weekend

Once you finish your turkey dinner Thursday and veg on the couch waiting for the ball games, the Christmas season officially begins. The madness of Black Friday shopping and Cyber Monday gives people the opportunity to finish their shopping...or start it, whichever fits your personality. Don't forget to shop locally to help the economy, their families deserve a good Christmas too. A few special shopping opportunities for unique items will be available at some of the local holiday activities such as the Gum Drop Shop in Orange next weekend.

West Orange starts the season off with its annual Christmas tree lighting celebration at 6 p.m., Monday, Dec. 2. Santa will visit with children and refreshments will be served. The event is held outside City Hall on Western Avenue.

Shangri La Botanical Gardens kicks off its lighted Christmas walks on Dec. 3. Stroll the gardens full of holiday decorations and

Christmas trees on Tuesdays through Saturdays from 6 to 9 p.m. through December 21. Admission is free, but donations of non-perishable food items to benefit Orange Christian Services.

A senior, mobility friendly and sensory sensitivity hour is offered 5 p.m. to 6 p.m. with no music, no flashing lights and smaller crowds for guests with mobility challenges or sensory sensitivities and their families. This sensory-friendly atmosphere provides an opportunity to view the lights at dusk. A limited number of wheelchairs will be available in the front office.

The Stark Museum of Art opened a special "Reindeer Trail" exhibit Nov. 20 tying in the artwork of reindeer and wildlife artwork in the museum's collection with a colorful and sparkling array of model reindeer decorated by area artists. The exhibit runs through Dec. 21.

DPS traffic enforcement increases Thanksgiving holiday

If you're on the road this holiday season, make sure you haven't been drinking.

Similar to most holidays, but especially around this time of the year, the Texas Department of Public Safety (DPS) ramps up its enforcement to make sure our roads are safe.

You will begin seeing more law enforcement starting on Wednesday, Nov. 27 through Sunday, Dec. 1. Troopers will be looking for people who are not wearing seat belts, driving while intoxicated, speeding and failing to follow the Move Over, Slow

Down law, among other traffic violations.

"With Thanksgiving around the corner, we remind everyone to stay vigilant on the roads," said DPS Director Steven McCraw. "There can be countless distractions this time of year, but your safety and the safety of others is what matters most. Take your time, avoid distractions and let's ensure everyone arrives to their destination this holiday season."

In 2023, DPS issued 41,093 warnings and citations, including 11,525 for speeding; 1,310 for driving without insurance; and 596

The best travel times on Texas roads during Thanksgiving

Texans are expected to take to planes, trains and automobiles in next week in massive numbers as travel for the Thanksgiving Holiday is supposed to climb past pre-pandemic numbers. AAA Texas projects a whopping 5.7 million Lone Star State residents will leave their home for the holiday.

More than 5 million Texans are expected to travel 50 miles or more before or on Thanksgiving Day – a day when families make the trek to a single household to dine on Turkey and cranberry sauce under one roof. The number of expected travelers is up 2.4% over 2019, the last holiday before the COVID-19 pandemic put a quash on travel plans, and up 1.3% from last year's Turkey Day.

"Well, Thanksgiving is one of the busiest holidays for travel. And this year,

AAA Texas expects to set new records across the board, from driving to flying and even cruising," said AAA Texas Public Relations spokesperson Daniel Armbruster. "Here in Texas, more than 100,000 additional people will be traveling this year compared to last Thanksgiving."

Some 5.3 million Texans are expected to drive for the holiday Thursday, November 21. And another 315,000 are expected to take flight while another 129,000 have plans to hop on a train, bus or boat. All of these figures soar past 2019 numbers and peak last year's festive travel figures.

"It's going to be a record Thanksgiving on the roads. And that means it's going to be very crowded, especially in major metro areas. The worst times to travel by car will be Tuesday and Wednesday afternoon before the holiday," Armbruster said. "Now, the best day to travel is actually on Thanksgiving Day itself.

And if you're returning home on Sunday, you're going to want to leave in the morning, because Sunday afternoon is expected to be very busy as well as Monday."

This aligns with information shared by the Texas Department of Transportation last year, when they

warned traffic backups could plague interstates from El Paso to San Antonio to Houston. And with even more drivers expected to hit Texas highways this holiday, the same stretches of road will likely be burdened on the days before and just after Thanksgiving.

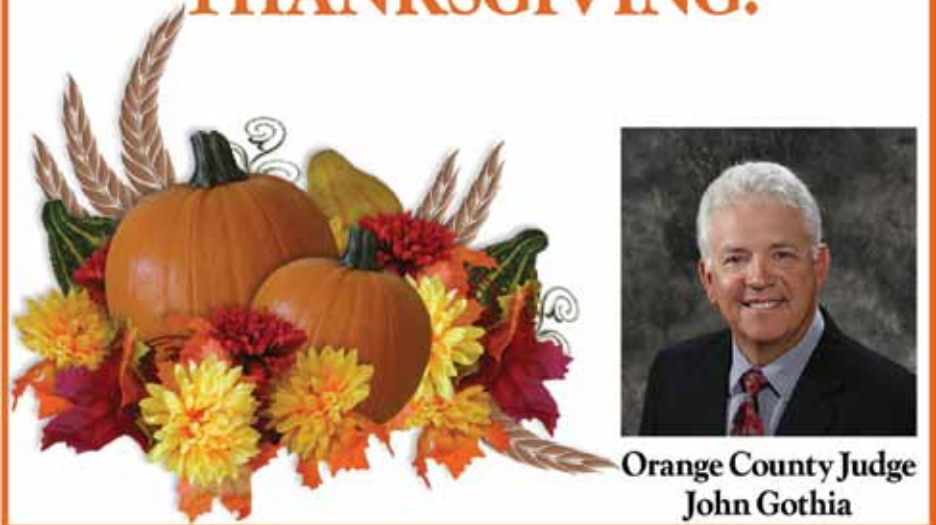

for seat belt and child seat violations during the holidays. That resulted in 54 felony arrests, 36 DWI arrests and 18 fugitive arrests.

DPS offers the following safety tips for the Thanksgiving holiday:

- **Don't drink and drive.** Make alternate plans if you are consuming alcohol.

- **Eliminate distractions** while driving, including the use of mobile devices. Texas law prohibits the use of portable wireless devices to read, write or send an electronic message unless the vehicle is stopped. If you're using a navigation device or app, have a passenger operate it so you can keep your eyes on the road.

- **Move Over or Slow Down for police,** fire, EMS, Texas Department of Transportation (Tx-DOT) vehicles and tow trucks stopped on the side of the road with emergency lights activated. Show the same courtesy to fellow drivers who are stopped on the side of the road. So far in 2024, there have been more than 9,284 Move Over, Slow Down violations.

- **Buckle up everyone in the vehicle** — it's the law. Slow down, especially in bad weather, heavy traffic, unfamiliar areas or construction zones.

Drive defensively, as holiday travel can present additional challenges.

- **On multi-lane roads, use the left lane for passing only.** Not only is it courteous driving and avoids impeding traffic, Texas law requires slower traffic to keep to the right and to use the left lane for passing only (when posted).

- **Don't cut in front of large trucks** and try not to brake quickly in front of them. They can't maneuver as easily as passenger vehicles and pickup trucks.

If you can Steer It, Clear It: If you are involved in a non-injury crash and your vehicle can be moved, clear the traffic lanes to minimize traffic impact. Leaving vehicles in a traffic lane increases traffic congestion and leaves those involved with an increased risk of harm or a secondary wreck. On some highways, if you don't move your vehicle when it's safe to do so, it's against the law.

- **Keep the Texas Roadside Assistance** number stored in your phone. Dial 1-800-525-5555 for any type of assistance. The number can also be found on the back of a Texas Driver's License.

- **Check your vehicle** to make sure it is properly maintained and always ensure your cargo is secure.

- **Report road hazards** or anything suspicious to the nearest law enforce-


ment agency.

- **Monitor weather** and road conditions wherever you are traveling. For road conditions and closures in Texas, visit Drive Texas

- **DPS would also like to remind Texans** about the iWatchTexas program, a critical resource for reporting suspicious activity within the community to help prevent dangerous attacks. It's especially important to be vigilant as people gather for parades, festivals and other community events. Tips can be reported via the website, the free iWatch iOS or Android mobile app or by calling 844-643-2251. All reports are confidential.

ISRAEL - HEZBOLLAH CEASE FIRE ANNOUNCED BY BIDEN

President Joe Biden on Tuesday touted a cease-fire deal between Israel and the militant group Hezbollah after more than a year of fighting between the two sides. Biden said he'd spoken with the leaders of Lebanon and Israel this afternoon and that both governments agreed to the cease-fire beginning at 4 a.m. local time Wednesday. "The fighting across the Lebanese-Israeli border will end. This is designed to be a permanent cessation of hostilities." Under the deal outlined by the president, the Lebanese army will take control of their own territory in the south, Hezbollah infrastructure will not be allowed to be rebuilt and Israel forces will withdraw over the next 60 days. Biden is still hoping for an agreement to end hostilities in Gaza. Toward the end of his speech, Biden turned his attention to the war raging in Gaza. "The people of Gaza have been through hell. Their world is absolutely shattered. Far too many civilians in Gaza have suffered far too much," Biden said, blaming Hamas for not negotiating a ceasefire in good faith over the last few months. "Hamas has a choice to make. Their only way out is to release the hostages, including American citizens, which they hold. In the process, bring an end to the fighting which would make possible a surge of humanitarian relief," the president said. Israeli Prime Minister Benjamin Netanyahu appeared in a televised address and pushed his cabinet to approve the deal as soon as possible. "The length of the cease-fire will depend on what happens in Lebanon. Lebanon's government is expected to vote on the deal on Wednesday.

TURNING BACK THE HANDS OF TIME

10 Years Ago-2014

My heart is heavy today because of the illness of so many personal friends. Don Harmon, one of the greatest persons I know is back in the hospital as I write this. Don has been transferred to Beaumont and is undergoing surgery to relieve fluid on his brain. He has always been a benefactor to anyone in need. He's full of goodness. Don and brother Corky have been partners for 57 years and Don's illness is weighing heavy on him. (Those two guys are now gone.) Mayor Don Peters is very ill also. He has been in the hospital but is home now. He's fighting a tough battle. Attorney Lynwood Sanders is recouping at Harbor Hospice after having his leg amputated. Our buddy and sweetheart Ms. Pearl Burgess, 94, is on the mend. She has been facing several health problems that would have defeated most normal people. Not Ms. Pearl. She's 98 pounds of toughness and a thousand pounds of optimism and positive attitude. Several months ago President Obama warned if the Congress didn't pass a bill before the end of the year he would take executive action. Congress ignored him and more or less dared him to do it. 20 Years Ago-2004

I love writing this column and I will miss the comments, yet I must try. Maybe Roy will let me reminisce once in a while. God bless all of you." (Editor's note: A great friend of many years, Louis was a historian. He often amazed us all with unknown tidbits about Orange County. He was a former state representative, the youngest ever at the time and also a former district attorney and a great defense attorney. Lou started his book but didn't get far before he became ill and died.) GONE BUT NOT FORGOTTEN: body of 23 year old John David Hannagan of Orangefield was recovered from the Neches River. His truck and trailer had been parked at Esther's Seafood several days. His 14-foot aluminum boat was recovered by two fishermen near the Entergy out flow area where Hannagan's body was found. C'EST TOUT TRUMP ELECTION INTERFERENCE CASE DISMISSED

After special counsel Jack Smith asked the judge to toss the case due to a long-standing Justice Department policy that bars the prosecution of a sitting president. Smith earlier Monday filed a motion to dismiss the case, as well as the appeal of Trump's classified documents case, ahead of Trump's impending inauguration, due to the DOJ's presidential immunity policy and not because the charges lacked merit. U.S. District Court Judge Tanya Chutkan dismissed the election interference charges against Trump without prejudice, leaving open the highly unlikely possibility of a future prosecution. In a two-page opinion, Judge Chutkan wrote that dismissing the case without prejudice is "appropriate" and would not harm the "public interest," agreeing with Smith's argument that Trump's immunity would not cover him when he leaves office. "Dismissal without prejudice is also consistent with the Government's understanding that the immunity afforded to a sitting President is temporary, expiring when they leave office," Chutkan wrote. However, it's extremely unlikely that any prosecutor would attempt to bring the same charges in the future, in part because the statute of limitations for the alleged crimes will have expired by the time Trump leaves office in four years. It seeks to keep the appeal in place for Nauta and De Oliveira, two Trump employees who pleaded not guilty to obstruction charges. "The appeal concerning the other two defendants will continue because, unlike defendant Trump, no principle of temporary immunity applies to them," the filing said. Trump however, with 34 felonies, plus other charges, is on the way to beating all the raps. So much for the law applying to everyone. Trump is the oldest ever elected president. Remembering Hank Williams

• Part Two of Two

Hank Williams was born in Mount Olive, Alabama on Sept. 17, 1923. When he was eight years old, Williams was given a guitar by his mother. His musical education was provided by a local blues street singer, Rufus Payne, who was called Tee Tot. From Tee Tot, Williams learned how to play the guitar and sing the blues.

Williams began performing around Georgia and Greenville areas of Alabama in his early teens. During his shows Williams would sing songs from his idol Roy Acuff, as well as several other country hits of the day. Hank Williams is the father of contemporary country music. Williams was a superstar by the age of 25. He was dead at the age of 29. Williams wrote a body of songs that became popular classics and his direct, emotional lyrics and vocals became the standard for most popular performers. Hank lived a life as troubled and reckless as that depicted in his songs. Hank met Audrey Mae Sheppard, a farm girl from Banks, Alabama, in 1943, while he was playing a medicine show.

The following year the couple married. Audrey became Hank's manager just before the marriage. By 1946, Hank was a local celebrity but he was unable to make much headway nationally. That year Hank and Audrey visited Nashville. Fred Rose, one of the heads of Acuff-Rose Publishing, liked Hank's songs and asked him to record two sessions for Sterling Records that resulted in two singles. Both of the singles, "Never Again" and "Honky Tonkin" were successful and Hank signed a contract with MGM Records in early 1947. Rose became the singer's manager and record producer. "Move It on Over," released later in 1947, became Hank Williams' first single for MGM.

By the summer of 1948, he had joined the Louisiana Hayride, appearing both on its tours and radio programs. "Honky Tonkin"

was released in 1948, followed by "I'm A Long Gone Daddy." Early in 1949, he recorded "Lovesick Blues." The single became a huge hit, staying at number one for 16 weeks and crossing over into the pop Top 25. Williams sang the song at the Grand Ole Opry, where he performed an unprecedented six encores. He had become a star. Hank and Audrey had their first child, Randall Hank, in the spring of 1949. Williams had no fewer than seven hits in 1949 after "Lovesick Blues," including the top fives, "Wedding Bells," "Mind Your Own Business," "You're Gonna Change," and "My Buckets Got a Hole in It." In addition to having a string of hit singles in 1950--including the number ones--"Long Gone Lonesome Blues," "Why Don't You Love Me," and "Moanin' the Blues," as well as the top ten's "I Just Don't Like This Kind of Livin'," "My Son Calls Another Man Daddy," "They'll never Take Her Love From Me," "Why Should We Try," and "Nobody's Lonesome for Me."

That same year, Williams began recording a series of spiritual records under the name of Luke the Drifter. Hank continued to rack up hits in 1951, beginning with "Dear John" and its flip-side, "Cold Cold Heart." He began to experience the fruits of crossover success appearing on the Perry Como television show and being part of a package tour that also featured Bob Hope, Jack Benny and Minnie Pearl. He had several other hits in 1951, including the number one "Hey Good Lookin'" and "Howlin at the Moon," "I Can't Help It (If I'm Still In Love With You)," "Crazy Heart," "Lonesome Whistle," and "Baby, We're Really in Love" which all charted in the Top Ten. Though his professional career was soaring, Hank Williams' personal life was beginning to spin out of control.

Hank's marriage to Audrey was deteriorating. In the fall of 1951, while on a hunting trip on his Tennessee farm Hank tripped and fell, re-activating a dormant back injury. Williams began taking morphine and other pain killers for his back and quickly became addicted. In January, 1952, Hank and Audrey separated for a final time. The hits were still coming fast for Williams however with "Honky Tonk Blues" which was number two in the spring. In fact he released five more singles that year. "Half As Much," "Jambalaya," "Settin the Woods on Fire," "You Win Again," and "I'll Never Get Out of this World Alive"

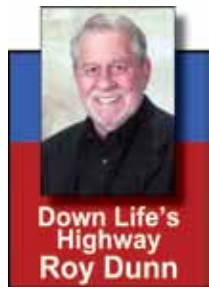
In spite of his success, he turned completely reckless in 1952, spending nearly all of his waking hours drunk and taking drugs, while he was frequently destroying property and playing with guns. Audrey and Hank were officially divorced. He was still playing the Louisiana Hayride but he was earning reduced wages. That fall, he met Billie Jean Jones Eshlimar. By October, they were married. She later married Johnny Harden, then Hugh Lea, an Orange attorney, after Harden was killed in an auto accident. Also in October Hank signed an agreement to support a baby--yet to be delivered--of one of his girlfriends, Bobbie Jett.

By the end of the year, he was having heart problems and Toby Marshall, a con-man doctor, was giving him various prescription drugs to help soothe the pain. Hank Williams was scheduled to play a concert in Canton, Ohio, on January 1, 1953. He was scheduled to fly out of Knoxville, TN, on New Year's Eve but the weather was so bad he had to hire a chauffeur to drive him to Ohio in his new Cadillac. Before they left for Ohio, Williams was injected with two shots of Vitamin B-12 and morphine by a doctor. Williams got in the backseat of the Cadillac with a bottle of whiskey and the teenage chauffeur headed

out for Canton. The driver was stopped for speeding and the officer noticed that Williams looked like a dead man. Williams was officially declared dead at 7 a.m. on January 1, 1953.

The last single released in his lifetime was "I'll Never Get Out of this World Alive." Hank Williams was buried three days later. His funeral drew a record crowd. Dozens of country music stars attended as did Audrey Williams, Billie Jean Jones and Bobbie Jett, who happened to give birth to a daughter three days later. "I'll Never Get Out of this World Alive" reached number one after his death and it was followed by a number of hit records throughout 1953, including the number ones "Your Cheatin heart," "Kaw-Liga" and "Take These Chains from My Heart." Hank Williams' impact never diminished. His songs have become classics, his recordings have stood the test of time and his life story is legendary. It's easy to see why he is considered by many as the defining figure of country music.

My teenage years were marked by Hank as I started Down Life's Highway. These two country giants, Acuff and Hank, took me from childhood to adulthood and here I am at age 90, still connected to them by their music. From time to time, I get Alexa to play their catalog of music I started listening to on the Louisiana Hayride and Grand Ole Opry on my battery radio.

The West Orange-Stark Mustangs football season came to a sudden end this past Friday night in Magnolia as the Waco La Vega Pirates advance to the third round of the Class 4A Division 2 playoffs.

La Vega defeated WO-S, 42-20, behind several big plays in a high-scoring second-half at Bulldogs Stadium in Magnolia.

La Vega led 7-0 at half-time courtesy of a 1-yard touchdown run by Pirates quarterback Kourtney Parr late in the second quarter as both defenses were able to keep each opposing offense limited in

For some strange and unknown reason it seems like the older I get the faster things tend to repeat themselves. At times I would swear the pages on the calendar flip by 2 months at time instead of just 1. Recently I just renewed my United States Coast Guard license for the 5th or 6th time and I started thinking about how much time that represented, especially knowing that its 5 years between each renewal.

As I stood next to the island in my kitchen and opened up my new set of Coast Guard documents I couldn't help but take a short trip down memory lane. As a guide you remember a lot things about a lot of different trips and eventually they all feel as if they have run together. There are however some things that always stick out like some of the bigger fish that have been caught and some of the crazier characters you encounter because they always come with a story.

Perhaps some of my favorite memories are when someone on my boat catches their first fish, I truly cherish opportunities like that because they are indeed special. Just recently I was fortunate enough to have had such a trip and it was like a shot in the arm for me, a reminder of why I enjoy guiding so much.

A few weeks ago I was approached by a friend of mine about taking his family out on a fishing trip because his 8 year old son was completely infected with "fishing fever". It seems that during a cub scout exercise the young man was introduced to fishing and wanted to pursue it as much and as soon as possible. My friend knew very little about the sport but wanted to give his son every opportunity to enjoy it so he did the next best thing by seeking out professional help. The goal was simple, take the young man out, catch a few fish, and teach him some basics that will enable him to not only learn about the sport but get better at the same time. I'm not sure who was more excited the day of the trip, the boy, his dad, or myself.

Our day started off with perfect conditions, flat calm and crisp temperatures, we could not have asked for any better situation. The bonus for me was the entire family decided to come along, both parents and 3 youngsters (2 boys and 1 girl) aged 8, 5, and 4. Even though it takes some extra patience to deal with the youngsters I generally enjoy each opportunity to take kids fishing and this would be no exception.

After getting everybody squared away with life jackets and basic safety rules we made a run out into the lake to look for working birds and schooling trout. It took us a few stops to finally figure out what was going on but eventually we figured it out. It was perfect as each child ended up with an adult being able to supervise them. The pattern for the trip was spinning rods and rattling corks with soft plastics tied beneath them, a combo the small trout and sand trout found irresistible. The first fish for each child was met with great excitement by all in attendance.

Easily the highlight of the day came towards the end of the afternoon as hefty 28 inch redfish obliterated the popping cork and proceeded to make a rather long run before deciding to really put up a fight. At this point each of the kids took turns battling the redfish while the others cheered enthusiastically. After we finally subdued the fish and lid it into the net you would've thought we had just won the World Series as the celebration ensued. I was as happy for them as they were to catch such a great fish. The genuine excitement and wonder on all their faces was priceless and I was certainly proud to be a part of it all.

In the days following that family trip I slipped back into the mode of routine trips with experienced fishermen and that brought on a whole new set of circumstances and things to be considered. I have often written about fishing in the winter and some of the things that should be on each anglers mind and the top of the list should be keeping yourself safe in the harsher elements. Cold water is unforgiving so the proper clothing and personal floatation device is a must. If you have never fallen in the water during those colder months all I can tell you is be prepared for what those temps will do to your body.

Speaking of being equipped properly a quality pair of waders is essential for all the big trout fishermen who will be slipping out of the boat in favor of a silent stalk on a big fish. For nearly 10 years now I have been using the breathable waders from Gulf Coast Waders and I have truly been impressed. I fish and duck hunt with the same waders and they hold up extremely well. In a recent conversation with the owner he told me he was having to close his operation down due to any number of reasons associated with the economy and that has me holding on tight to my remaining few pair I have stowed away.

Almost as important as the waders you wear is the type of clothing you choose for warmth. There are several brands of highly technical thermal garments which won't cause you to feel bulky or uncomfortable. Under Armour Cold Gear is my personal go to base layer followed by fleece pants and pullovers. Quality socks cannot be overlooked either because there is no substitute for warm dry feet on those long cold winter wades. Cover all that up with a quality waterproof jacket with Velcro cuffs and you should be set for a day on the water.

Its like the old saying goes "its better to have them and not need them than to need them and not have them".

GOOD. 74 degrees. Very nice catches of speckled trout in the north end of Sabine Lake with live shrimp under a popping cork. Make long drifts off of Pleasure Island Point. Then head into the Inter-coastal Waterways targeting drops in our rock piles for limits of very good redfish, with some trout mixed in.

After the cold front rolled through we focused our efforts in the Neches River. Very nice redfish, drum and sheepshead were biting on the points in the rock piles and buoys with live shrimp under a popping cork. Some catches of freshwater catfish as well.

• **Bolivar**

GOOD. 75 degrees. Water temperature staying in the upper 70s, but should cool after the forecasted north winds. Water levels swapping back-and-forth this week between super high and average low tides. Anglers are still catching plenty of redfish everywhere. There are plenty of big croakers along with sand trout, black drum, speckled trout, and crabs caught along the jetty with a few small stingrays and sharks.

Reminder, flounder are catch and release only through December 14. The surf is producing lots of redfish and black drum, a few gafftop, lots of small stingrays, and bigger sharks along the whole peninsula with high activity towards Gilchrist/High Island mainly.

• **Trinity Bay**

SLOW. 73 degrees. Redfish are tight to drains and reefs early in the mornings being caught on WACKy Shad XLs peppered pumpkin color with a chartreuse tail married with a 3/8 ounce rattling jig head working fast triple twitch-

es and letting it fall. Most bites are on the fall, right before the jig hits the bot-

tom again. Trout are on mud and sand mixed flats with scattered shell being

caught with live shrimp under a popping cork with 3-4 foot leaders and in good current in drains with a 3/8 ounce jig head married with the WACKy Fluke in the code red color working aggressively to entice a bite on the way back to the boat. Always fish with the current. Drum and sheepshead are tight to rock lines being caught on live shrimp under a popping cork. Remember, always wear your kill switch and pay attention to the weather. Be sure to plan your trip prior to getting on the water to map out reefs. Report by Captain Zackary Scott, Zack Attack Fishing.

• **East Galveston Bay**

GOOD. 72 degrees. If the birds are working up near the shoreline or in shallow water hovering the surface, the redfish are feeding on shrimp. Shrimp imitation lures with Fish Smack popping corks, with 14-18 inch leaders have still been producing the most bites.

Wake up the ghosts! Texas and Texas A&M rivalry that dates to 1894 is reborn

Any Texas or Texas A&M player has heard the lore of the rivalry between the two schools, a grudge match that dates to 1894.

But for more than a decade — two generations of college football players — that's all it has been: Ghostly memories of great games and great plays made by heroes of the distant past.

That changes this week when one of college football's great rivalries is reborn. Third-ranked Texas (10-1, 6-1) and No. 20 Texas A&M (8-3, 5-2) meet Saturday night for the first time since 2011, with a berth in the Southeastern Conference championship game on the line.

"Guys that have been in my position and bleed burnt orange, they have not gotten to play this game," said Texas fourth-year junior safety Michael Taaffe, who grew up in Austin. "Remember them when you step on Kyle Field."

For Aggies fans, who have carried the misery of Texas' 27-25 win in 2011, getting the Longhorns back in front of a frenzied crowd in College Station is a chance for some serious payback.

"I was born and raised an Aggie, so I've been dreaming about playing in this game my whole life," Texas A&M offensive lineman Trey Zuhn III said.

Zuhn played high school football in Colorado, but his parents and grandparents attended A&M. At SEC media days back in August, Zuhn said his family would turn Texas gear upside down in stores. He keeps a picture of a longhorn in his room, hanging upside down, of course.

"It should be the most amazing atmosphere that I've ever experienced," Zuhn said. "I can't wait for that, and I feel bad for Texas having to play in that."

Texas players said they are ready.

"That place is going to be rocking," Texas senior cornerback Jahdae Barron said. "It's good to go on the road and play in hostile environments."

The Longhorns have overcome big and loud road crowds before. They won at Alabama in 2023. They won at Michigan and Arkansas, another old rival, this year. The Longhorns have won 10 in a row on an opponent's home field.

"When the hate is on us,

we love it. We enjoy it," Taaffe said.

But some former Texas players say the current group has faced nothing like what awaits them in College Station.

Playing at Texas A&M is more than just noise and a lot of "Horns down" hand signals. The "Aggie War Hymn" fight song calls for Aggies to "Saw varsity's horns off."

Beating Texas is their passion, said former Longhorns All-American offensive lineman Dan Neil, who won at Texas A&M in 1995. He calls that win one of the best of his career.

"I was done showering and getting ready to leave, and their fans were still standing outside the locker room screaming and throwing things," he said. "The (Texas) players have no idea what they are walking into. They have no clue. No one on that team has walked into that stadium in burnt orange."

The rivalry broke up when Texas A&M left the Big 12 for the SEC in 2012. The Aggies have twice finished tied for second but have otherwise found little success there.

Texas is in its first year in the SEC and has smashed its way to the top. Texas is the only SEC team

with one loss this late in the season, which would make beating Texas that much sweeter for A&M.

"The hype is definitely saying it's a rivalry. History says it's a rivalry, but for us, it's the football game we have this week," Texas senior center Jake Majors said. "It's important for us to not let the environ-

ment, the game, get the best of us. ... I get to go out there and play not only for me and my team, but for the guys who came before me, so that's a true honor to have."

Even though the game hasn't been played since 2011, there has always

been an element of the rivalry simmering under the surface, Texas A&M coach Mike Elko said.

Elko is in his first year as the Aggies' coach, but he was the Texas A&M defensive coordinator under Jimbo Fisher from 2018-2021.

"Even though it hasn't been played, it just doesn't feel like it's ever really left the fabric. I really don't think it's as removed from the psyche as maybe it feels," Elko said. "I think our kids are very much aware of what this is all about."

7 Great Moments in Texas Turkey History

Every year, the President of the United States pardons a turkey before Thanksgiving, protecting a lucky fowl from becoming the main course at someone's dinner table. But did you know it was a Texan, President George H.W. Bush, who made pardoning a turkey at the White House an official tradition? This is just one of the great moments in the Lone Star State's history with Thanksgiving and turkey.

1598 – Forget Plymouth. According to legend, Texas held the “first Thanksgiving” when Spanish expedition leader Juan de Oñate landed in San Elizario after a long and treacherous journey to reach the Rio Grande. They feasted on game provided by the Spaniards and fish from the Manso tribe and celebrated a Mass—all to celebrate this new land that Spain would reign over for 200 years.

1893 – The Texas Panhandle town of Turkey gets its name. Best known as the hometown of Western swing icon Bob Wills, Turkey was originally called Turkey Roost because of all the wild turkeys that lived along a nearby creek called—wait for it—Turkey Creek.

Eventually, “Roost” was dropped from the name. In 2011, PETA sent a letter to the mayor of Turkey, asking him to change the town's name to Tofurkey. His response? No furking way. (Actually, the mayor's office had no comment.) Mark your calendars: April 30 is the 50th anniversary of Turkey's annual Bob Wills Day.

1912 – The first Turkey Trot is held in Cuero. In the early 1900s, this southeast Texas town had a thriving turkey processing industry, and instead of driving turkeys to facilities in vehicles, local farmers moved the gobbling products on foot (like a cattle

drive but with wings). Someone had the grand idea of creating an event around these drives, and in November 1912, 30,000 people showed up in Cuero to see thousands of turkeys make their way through the streets.

Today, the town hosts an annual Turkeyfest with tur-

key races, a parade, barbecue cookoffs, and other festivities.

1989 – President George H.W. Bush makes pardoning the Thanksgiving turkey an official annual tradition at the White House. He wasn't the first president to save a turkey

from slaughter (Lincoln, Kennedy, and Reagan are among the presidents who unofficially pardoned turkeys while in office), but Bush was the first to declare this momentous occasion a duty of the chief of state every year. “Let me assure you, and this fine tom turkey, that he will not end up on anyone's dinner table,” he said. “Not this guy. He's presented a presidential pardon as of right now—and allow him to live out his days on a children's farm not far from here.”

1993 – Largest turkey in Texas bagged. According to the Texas Tribune, the record for the largest turkey ever killed in Texas was set in 1993, with the unlucky bird weighing 30.75 pounds. It was registered with the National Wild Turkey Federation. No word on how many pounds of turkey hash were made from the leftovers following Thanksgiving.

2003 – Technology arrives at the White House,

and President George W. Bush becomes the first president to pardon turkeys chosen by the American people through online voting.

“This year, for the first time, thousands of people voted on the White House website to name the national turkey and the alternate turkey. Stars and Stripes beat out Pumpkin and Cranberry. And it was a neck-to-neck race,” he said, as the crowd roared with laughter.

2011 – The Dallas Turkey Trot sets a Guinness World Record for largest gathering of people dressed as a turkey. The history of this human foot race dates to 1967, when 92 runners showed up to participate in an 8-miler. In 2011, 661 runners attended in turkey costumes, giving Dallas the record.

Now close to 40,000 people participate in the annual race making the Dallas Turkey Trot the largest race of its kind in the country.

Hunters Reminded to Report Their Harvest During Upcoming Antlerless Season

AUSTIN – As the four-day antlerless deer season, Nov. 28-Dec. 1, begins this week in 21 counties, Texas Parks and Wildlife Department (TPWD) reminds hunters to report their harvest using either the free Texas Hunt & Fish mobile app (for iOS and Android) or the Texas Hunt & Fish web page.

Hunters must complete mandatory harvest reporting for any antlerless deer harvested during the four-day doe season, along with any antlerless deer harvested during the youth-only and muzzle-

loader seasons within 24 hours of their hunt., hunters must report their harvest using either the free Texas Hunt & Fish mobile app (for iOS and Android) or on the Texas Hunt & Fish web page.

Counties required to report their harvest include Austin, Bastrop, Caldwell, Colorado, Comal (East of I-35), De Witt, Fayette, Go-liad (North of US 59), Gonzales, Guadalupe, Hays (East of I-35), Jackson (north of US 59), Karnes, Lavaca, Lee, Travis (East of I-35), Victoria (North of US 59), Waller, Washington, Wharton (North of US 59) and Wilson.

Additionally, hunters in

the four counties that remain dedicated to archery-only hunting (Dallas, Grayson, Rockwall and Collin) must report all white-tailed deer harvests within 24 hours through the Texas Hunt & Fish App during all white-tailed deer seasons.

Accurate reporting in mandatory reporting counties allows agency wildlife biologists to properly study hunting impacts on local deer populations and develop more hunting opportunities in the future.

Thanksgiving Gives Us Eyes for God

When I was 8 years old, I had an eye exam. As I tried to make out the letters on the chart, I got so many wrong that the doctor thought I was joking. But this was no joke; I was very nearsighted.

A week later, when I got my first pair of glasses, I was stunned. I could read street signs, recognize people's faces at a distance, see far-off mountains and individual leaves on trees. I could see more clearly than ever. That's a lot like gratitude. Gratitude is like glasses, as it helps us see the glory of God's mercy more clearly. And therefore, because our greatest joy is seeing God's glory, gratitude increases our joy.

Gratitude Helps Us See

For many years, I did not experience more joy in God through gratitude. I dutifully thanked God for his blessings, but because I did not understand thanksgiving, my gratitude did not help me see God's glorious mercy, and so it did not increase my joy.

The problem was that I saw thanksgiving mostly as an obligation to be fulfilled. God had done something for me, so now I owed him gratitude. And once I had said, "Thank you," my debt was paid,



and I moved on to something else.

But that's not how the Bible talks about thanksgiving. Consider, first, how the Bible often links thanksgiving with joy.

Let us come into his presence with thanksgiving; let us make a joyful noise to him with songs of praise! (Psalm 95:2)

Rejoice in the Lord, O you righteous, and give thanks to his holy name! (Psalm 97:12)

Let them offer sacrifices of thanksgiving, and tell of his deeds in songs of joy! (Psalm 107:22)

So, joy and thanksgiving are connected. But how?

We might think the connection is obvious: when we give thanks, we rejoice in what God has given. Think of the joy we feel in getting promoted,

or being healed. Surely, joy in God's gifts is part of gratitude. But it's not the only joy of gratitude. And it's not the greatest joy.

Gratitude's Greatest Joy

We can discover the greatest joy of gratitude by noticing how often God's word links thanksgiving with praise.

I will thank you in the great congregation; in the mighty throng I will praise you. (Psalm 35:18)

I will praise the name of God with a song; I will magnify him with thanksgiving. (Psalm 69:30)

Then one of [the ten lepers], when he saw that he was healed, turned back, praising God with a loud voice; and he fell on his face at Jesus' feet, giving him thanks. (Luke 17:15-16)

I was used to distinguishing thanksgiving

and praise. And of course, they are different: thanksgiving does focus more on what God does, and praise on who God is. But these verses show there's a connection. The fact that thanksgiving is linked with praise shows that thanksgiving does not ignore who God is. Thanksgiving helps us see and praise who God is. And this act of seeing and praising God is thanksgiving's greatest joy.

How does this work?

Putting on the Glasses

Let's say you get a promotion and want to thank God. Thankfulness starts with seeing the value and the mercy of God's gifts.

So, you would remind yourself of the value of this promotion — maybe it's more interesting work, higher pay, and a better career path. Then, you

would ponder the mercy of this promotion — that because you are a sinner, deserving only hell, this gift is an infinitely costly mercy, bought for you by Jesus's suffering on the cross.

Then, as you thank God, recounting both the worth and the mercy of this promotion, the experience will be like putting on glasses — you see even more clearly the glory of God's grace in Christ. And this will increase your joy in God, because beholding God's glorious mercy is our all-satisfying joy.

So, when God calls us to give thanks, he's not just calling us to thank him for what he's done. He's calling us to rejoice in who he is, as displayed in what he's done. And that's why Christian Hedonists love to thank God: thanking God leads to seeing more of God, and seeing more of God is our greatest joy.

Growing Toward Gratitude

How can we thank God in a way that increases our joy in God? Here are five steps.

- First, ask for the Spirit's help. The goal of thanksgiving is seeing and feeling the glory of God's mercy, and we can't do that without the Spirit's work. So, ask.

- Second, ponder the

value of God's gifts. Consider the value of each gift. Think about health, friends, the food in front of you. Think especially about the Savior, whose death paid for your sins and purchased fullness of joy in him forever.

- Third, think about the mercy of God's gifts. Not only do we not deserve these gifts, but because of our sin, all we deserve is God's judgment. Ask God to help you see that, so you feel more wonder at the grace and mercy displayed in this blood-bought gift.

- Fourth, do this until you see and feel more of God's glorious mercy. Keep praying for the Spirit's Jesus-revealing work, and keep thinking about the worth and mercy of God's gifts, until you sense more of God's glorious mercy in Christ.

- Fifth, express your thanksgiving and joyful praise to God. Thank him for his gifts, expressing the worth of each gift and the mercy of each gift. And rejoice in how each gift displays the glory of God's grace to you in Christ.

We all need help seeing God's glorious mercy. And gratitude, like glasses, can help. So, for the sake of your joy in God, put on the glasses of gratitude. And see.
